

# Supplier Diversity, Equity, and Inclusion Policy

**Purpose:** Itron, Inc. is committed to fostering an inclusive and equitable business environment by encouraging the participation of diverse Suppliers. This Supplier Diversity, Equity, and Inclusion Policy outlines our commitment to engaging Suppliers from various backgrounds and promoting opportunities for underrepresented businesses to thrive in partnership with Itron.

**Scope:** This policy applies to all Suppliers, defined as direct and indirect suppliers and vendors providing goods and/or services to or on behalf of Itron, including its affiliates. The policy is integral to Itron's business practices, encompassing both domestic and global operations.

Policy Statement: Itron is committed to:

- Ethnic or racial minorities (e.g., Asian, African American, Hispanic)
- Women (of any race or ethnicity)
- LGBTQ community members
- Veterans or Service-Disabled Veterans
- Persons with Disabilities
- Small businesses, as defined by local country-specific regulations



Program Objectives: Itron's Supplier Diversity, Equity, and Inclusion Program aims to:

## 1. Expand Supplier Opportunities:

o Increase the number of qualified diverse businesses in our supply chain.

## 2. Identify Qualified Diverse Suppliers:

 Source financially stable and capable diverse business enterprises that meet Itron's quality, service, and pricing standards.

# 3. Integrate Diverse Suppliers:

 Engage qualified minority, women, and diverse-owned businesses as regular
Suppliers when they provide competitive bids and meet Itron's requirements for quality and financial stability.

#### Training:

 Relevant Itron employees will receive training on Supplier diversity to ensure alignment with the policy and program goals.
